In exercise of the powers conferred by section 34 of the Public Health Law (2002 Revision) the Cabinet makes the following Regulations —

Citation

1. These Regulations may be cited as the Control of Covid-19 (Amendment) (No.2) Regulations, 2020.

**Insertion of regulation 3A in the Control of Covid-19 Regulations, 2020 –
entry into the Islands for medical purposes**

2. The *Control of Covid-19 Regulations, 2020*, in these Regulations referred to as the “principal Regulations”, are amended by inserting after regulation 3, the following regulation —

“Entry into the Islands for medical purposes

- 3A.** (1) Notwithstanding regulation 3, the Cabinet may, after consultation with the Medical Officer of Health, permit any person to land in the Islands for medical purposes.
- (2) A person referred to under paragraph (1) —

- (a) shall comply with the directions of the Medical Officer of Health with regard to isolation and any additional health monitoring for the purposes of preventing, controlling or suppressing the spread of the virus; and
 - (b) who shows respiratory symptoms or symptoms of the virus shall be managed at a facility and in such manner as specified by the Medical Officer of Health,
until the Medical Officer of Health determines that the person is no longer a health risk to the public.
- (3) A person who contravenes paragraph (2) commits an offence and is liable on conviction to a fine of one thousand dollars and to imprisonment for six months.”.

Amendment of regulation 4 - restrictions on arrival of all persons to the Islands to control the spread of Covid-19

3. The principal Regulations are amended in regulation 4(2) by repealing paragraph (c) and substituting the following paragraph —
- “(c) the person shows respiratory symptoms or symptoms of the virus, the person shall be managed at a facility and in such manner as specified by the Medical Officer of Health until the Medical Officer of Health determines that the person is no longer a health risk to the public.”.



Insertion of regulation 4A – power to exempt persons from compliance with regulation 4

4. The principal Regulations are amended by inserting after regulation 4 the following regulation —

“Power to exempt persons from compliance with regulation 4

- 4A.** (1) The Cabinet may, after consultation with the Medical Officer of Health, exempt a person or category of persons from any of the requirements in regulation 4.
- (2) Notwithstanding paragraph (1), a person who is exempted —
- (a) shall comply with the directions of the Medical Officer of Health with regard to isolation and any additional health monitoring for the purposes of preventing, controlling or suppressing the spread of the virus; and
- (b) who shows respiratory symptoms or symptoms of the virus shall be managed at a facility and in such manner as specified by the Medical Officer of Health,
- until the Medical Officer of Health determines that the person is no longer a health risk to the public.
- (3) A person who contravenes paragraph (2) commits an offence and is liable on conviction to a fine of one thousand dollars and to imprisonment for six months.”.
